

# Board of Directors Meeting Thursday, January 15<sup>th</sup>, 2015 at 2:30 pm

**Quorum**: Present at the Board meeting was Jeri Haas/President, Paul DePercin/ Vice President; Jane Rodgers/Secretary; Darlene Curtin/Director, Bob Poglitsch/ Director, Howard Grubb/Treasurer and Cathy Lieberman/Director.

## **President's Report:**

**2015 Payments/Invoices:** Jeri reported that VCC no longer provides coupon books.

**Vandalism: Criminal mischief**. Jeri reported that the bulletin board on fire. This is the third notice of criminal mischief in the last month in the area.

Jeri asked that everyone please be vigilant and call 911 if you see any nefarious activity. 2 neighbors have reported suspicious persons in their yard that does not belong there. This is for your own safety! Please lock your doors, carry your phones and keys at all time.

New Owners: Jeri welcomed new owners - Anita and Dick Sullivan 800 Bayport Circle to The Villas of Chestnut Creek.

**Project on Lake 9**: Final cost to 20 families around the lake will have an assessment for their share of the drainage that is going to be done. Jeri presented the design. Final figure to the Villas to be split equally between the association and members. The total cost of the project is \$5,000. \$2,500 will be billed to the owners. Each owner will be billed a one time only fee of \$125 per household. They anticipate the work to be finished in 30 and 45 days.

**Special Assessment discussion**: Jeri asked Michelle if a special assessment is needed from the Board to the owners. Michelle reported that it appears that the administrative work and vote should be done by the Master but she would be very happy to help the Villas to get the mailing to the Villas of Chestnut Creek owners.

Irrigation report: No calls this month.

**Landscaping**; Cathy reported that met with Jason from Hoskins. Five (5) lawns in the association have a lack of a top dressing. The seed would only be Bermuda and that is what they recommend.
